



## **TOKYO 2009 ASIAN YOUTH PARA GAMES**

### **ELIGIBILITY CODE**

Understanding that as an athlete/team official in the Tokyo 2009 Asian Youth Para Games, I am participating in an event which has ongoing international and historical significance, and in consideration of the acceptance of my participation therein,

*"I agree to be filmed, televised, photographed, identified and otherwise recorded during the Tokyo 2009 Asian Youth Para Games under the conditions and for the purposes now or hereafter authorized by the Asian Paralympic Committee (APC) in relation to the promotion of the Asian Youth Para Games and the Paralympic Movement."*

*"I agree that all photographs and moving images taken by me at the Tokyo 2009 Asian Youth Para Games, including those of athletes competing within any Paralympic venues, shall be used solely for personal and non-commercial purposes, unless prior written consent is obtained from the APC."*

*"I agree to comply with the IPC.APC Handbook, the IPC Anti-Doping Code, APC Accreditation Manual, the IPC Classification Guide, and the Sports Technical Rules of the sport (s) in which I am participating, as valid for the Tokyo 2009 Asian Youth Para Games ('the Tokyo Rules')."*

I understand that these documents can be found on or linked through the APC website, and I am aware of their content, in particular the dispositions of the APC Eligibility Code:

- being entered through my National Paralympic Committee (NPC);
- accepting the criteria of eligibility, qualification and participation laid down by the APC and the International Paralympic Sport Federations (IPSFs);
- abiding by the principles of fair-play and non-violence and behaving myself accordingly during the Tokyo 2009 Asian Youth Para Games;
- not taking any substance or using methods prohibited by the IPC Anti-Doping Code;
- not allowing my image and/or name in relation to my sport performance(s) during the Tokyo 2009 Asian Youth Para Games to be exploited by third parties for commercial purposes without prior approval by the APC;

- not conditioning my participation in the Tokyo 2009 Asian Youth Para Games on any financial return whatsoever;
- abiding by the APC rules and regulations for manufacturer trademarks on clothing and equipment;
- abiding by the classification rules of my IPSF and of the APC;

### **ACCEPTANCE OF SPORTS TECHNICAL SUPREME AUTHORITY**

I recognize and accept that the sports technical rules, being all rules which relate to competition, field-of-play and classification, for my sport during the Tokyo 2009 Asian Youth Para Games are under the authority of the respective IPSF and the APC and that any disputes which arise shall be resolved by the APC whose decision on such matters is final and enforceable.

I acknowledge and accept that decisions relating to the sports technical rules are not subject to further appeal beyond the decision made in the sport-specific appeal processes as set out in the respective sports technical rules or classification appeal processes as set out in the Tokyo 2009 Asian Youth Para Games Classification Guide. I shall not institute any claim, arbitration or litigation, or seek any other form of relief in any other court or tribunal in relation to such decisions.

### **ACCEPTANCE OF BINDING ARBITRATION**

On all matters outside the realm of sports technical rules, I agree that any dispute arising during the Tokyo 2009 Asian Youth Para Games that is beyond the scope of the rules established by my NPC, the Organizing Committee of the Tokyo 2009 Asian Youth Para Games (TAYPOC), IPSF and the APC, shall be submitted exclusively to the Court of Arbitration for Sport (CAS) and shall be determined in accordance with the CAS Ad hoc Arbitration Rules for the Tokyo 2009 Asian Youth Para Games. The decisions of CAS are final, non-appealable and enforceable.

I shall not institute any claim, arbitration or litigation, or seek another form of relief in another court or tribunal. I acknowledge and accept that the CAS will be present during the Tokyo 2009 Asian Youth Para Games.

In the event of any conflict between the rules of the IPSF, and the APC, the rules of the IPC shall prevail.

The Tokyo Rules and the corresponding dispositions have been brought to my attention by my NPC and/or my National Sports Federation (NSF).

**ACCEPTANCE OF RISK**

I acknowledge that:

"I participate in the Tokyo 2009 Asian Youth Para Games at my own risk; I will take all reasonable measures to protect myself from the risks of participation; and I am responsible for all property I bring on to the Tokyo 2009 Asian Youth Para Games sites and that the TAYPOC and the APC accept no responsibility for any loss or damage to this property."

"I release TAYPOC, the APC and the IPSF(s) governing my sport(s), and their respective executive members, directors, officers, employees, volunteers, contractors or agents, from any liability (to the extent permitted by law) for any loss, injury or damage suffered in relation to my participation in the Tokyo 2009 Asian Youth Para Games.
