

IPC General Rights

The IPC General Rights are owned by the IPC and include all rights of whatever kind or nature in respect of the terms "Paralympics" and "Paralympic", the IPC motto, flag and anthem, the Paralympic Symbol (Three Agitos design) and any other trademarks, logos and other indicia used or intended to be used in the context of the Paralympic Movement, such as mascots, posters and any artistic, orthographic, or visual representations or designations.

Any use made of the Paralympic Symbol (Three Agitos design) shall be in compliance with the requirements of the IPC Graphic Standards Manual (as it may be amended from time to time).

Asian Para Games Proprietary Rights

The Asian Para Games Proprietary Rights are defined as all Asia Para Games Marks and Championship Designs developed by the LOC relating to the Asian Para Games.

The Asian Para Games Proprietary rights are the exclusive property of the APC that owns all rights of whatever kind or nature concerning their organization, exploitation, broadcasting, marketing and reproduction by any means whatsoever and of any event or incident which occurs during the Asian Para Games which is connected to or associated with the competition. Therefore, the LOC is required to assign to the APC the copyright, design and other proprietary rights in and to the APC. If the LOC enjoys any so called 'moral rights' in any of the Asian Para Games Proprietary Rights, the LOC will waive those rights in favour of the APC. The LOC will ensure that it has an effective written assignment of all ownership rights in any of the Asian Para Games Proprietary Rights which are designed or created by a third party on behalf of the LOC.

If the LOC designs an emblem, mascot, trademarks, logos and other indicia relating to the Asian Para Games (the "**Asian Para Games Marks**") that such Asian Para Games Marks are approved by the APC in consultation with the IPC, incorporate the designated official name of the competition and are used at all times in a logical and consistent manner when referring to and in connection with competition.

The LOC must design the following graphic, visual, artistic and intellectual works or creations with respect to the Asian Para Games (the “**Asian Para Games Designs**”) all subject to approval by the APC in consultation with the IPC:

- (i) Victory medals and any moulds relating thereto;
- (ii) Victory and Commemorative Diplomas;
- (iii) Asian Para Games Tickets;
- (iv) Official Publications;
 - Stationary (letterhead, forms, reports)
 - Asian Para Games Registration Package
 - Official Asian Para Games Programme
 - Technical Manual
 - Media Guide
 - Asian Para Games Officials Guide
 - Final Results Books/CD
 - Post-competition Report - detailed
 - Post-competition Report – general
- (v) Official Website;
- (vi) databases and statistics relating to the Asian Para Games, including those related to athletes, medical-related, purchasers of Asian Para Games tickets, licensing products and persons registering or making inquiries with respect to Asian Para Games -related services.

The design of any such Asian Para Games Designs shall be subject to the prior written approval by the APC and the IPC.
